INTRODUCTION

- Live Fx Hub Limited is a licensed Forex service provider registered under the Financial Services Regulatory Authority (FSRA). The company is registered at Ground Floor, La Place Creole Building, Rodney Village, Rodney Bay, Gros-Islet, St. Lucia, with registration and license number 2025-00768.
- Live Fx Hub is running the “Live Fx Hub 50% Credit Bonus Promotion” (hereinafter referred to as the “Promotion”). By participating in this Promotion through www.livefxhub.com, the client agrees to be bound by the following Terms & Conditions.

1. INTERPRETATION OF TERMS

- Account – A live trading account registered under Live Fx Hub via the Client Portal.
- Balance – Total funds available in the account excluding credit bonus and floating profit/loss.
- First-Day Deposit – Total deposit amount made on the first deposit day based on server time.
- Minimum Deposit – A deposit equal to or greater than USD \$100 or based on selected Live Fx Hub account type.
- Promotion Period – February 1, 2026 (00:00) to April 30, 2026 (23:59).
- Credit Bonus – Trading credit provided by Live Fx Hub after meeting eligibility requirements.
- Minimum Traded Lots – Required trading volume before credit withdrawal eligibility.
- Standard Business Terms – The main trading agreement between the Client and Live Fx Hub.

4. SPECIFIC PROGRAM TERMS

4.1). This Promotion applies to Forex, Commodities, Indices, Metals CFDs and other instruments available on the Live Fx Hub platform.

4.2). Applicable for Live Fx Hub supported trading platforms and approved account types only.

4.3). Credit Bonus is tradable but not withdrawable until trading requirements are met.

4.4). Any withdrawal or internal transfer before meeting trading volume requirements may cancel the bonus automatically.

Example:

Client deposits \$2,000 and receives \$1,000 credit bonus.

- If trading volume requirement is not completed and withdrawal occurs, the credit bonus will be removed.
- If equity drops below the bonus amount due to trading losses, the bonus may be cancelled automatically.
